





# An introduction to the Greater Bay Area

The concept of the Guangdong-Hong Kong-Macau Greater Bay Area (GBA) was first raised in 2016 as part of China's 13<sup>th</sup> Five Year Plan. The GBA comprises the two Special Administrative Regions of Hong Kong and Macau, as well as the nine municipalities of Guangzhou, Shenzhen, Zhuhai, Foshan, Huizhou, Dongguan, Zhongshan, Jiangmen and Zhaoqing in Guangdong Province. The GBA's mission is to deepen cooperation amongst Guangdong, Hong Kong and Macau, leveraging the respective advantages of each; facilitate integration within the region; and promote coordinated regional economic development, resulting in an international first-class bay area ideal for working, living and travelling.


